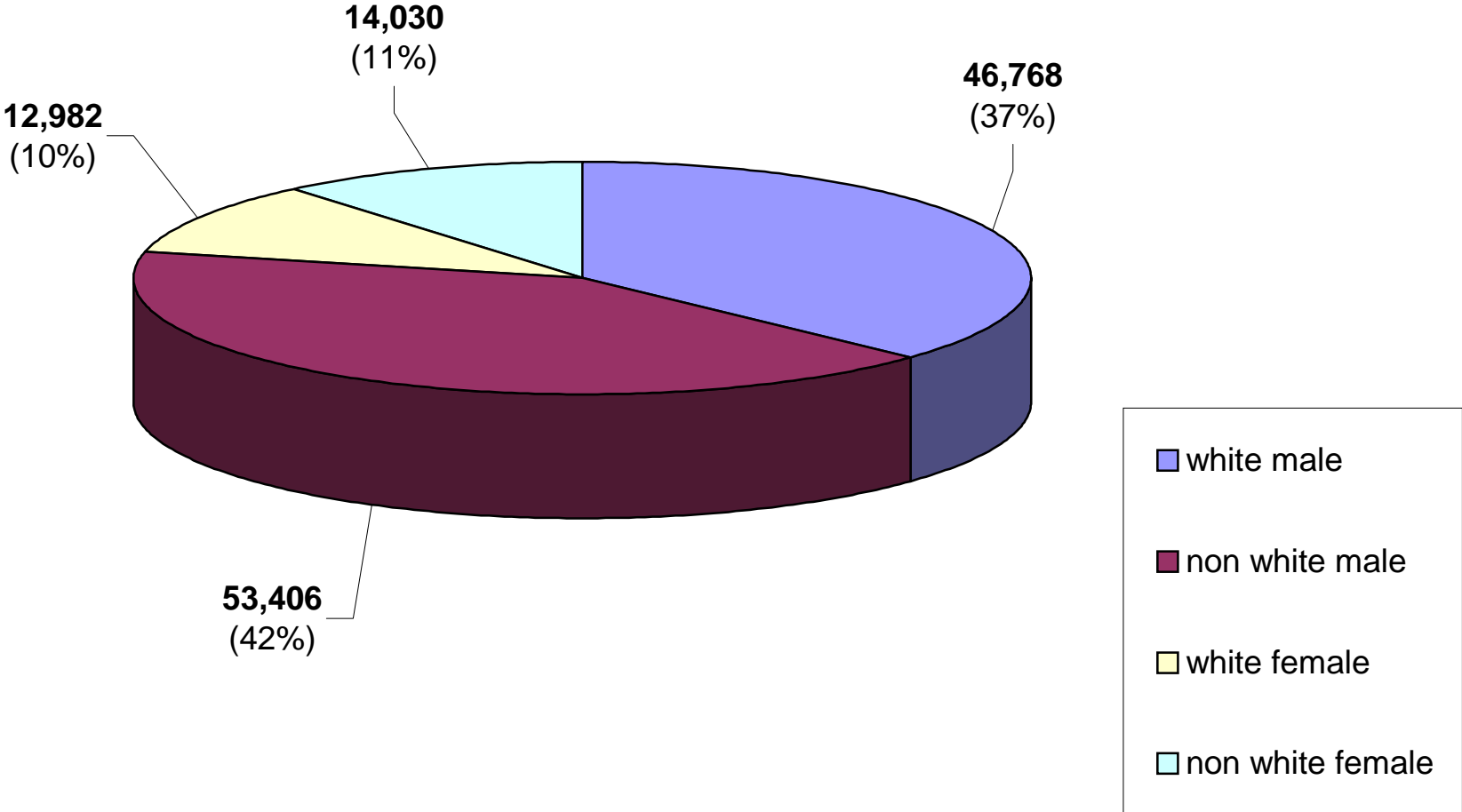
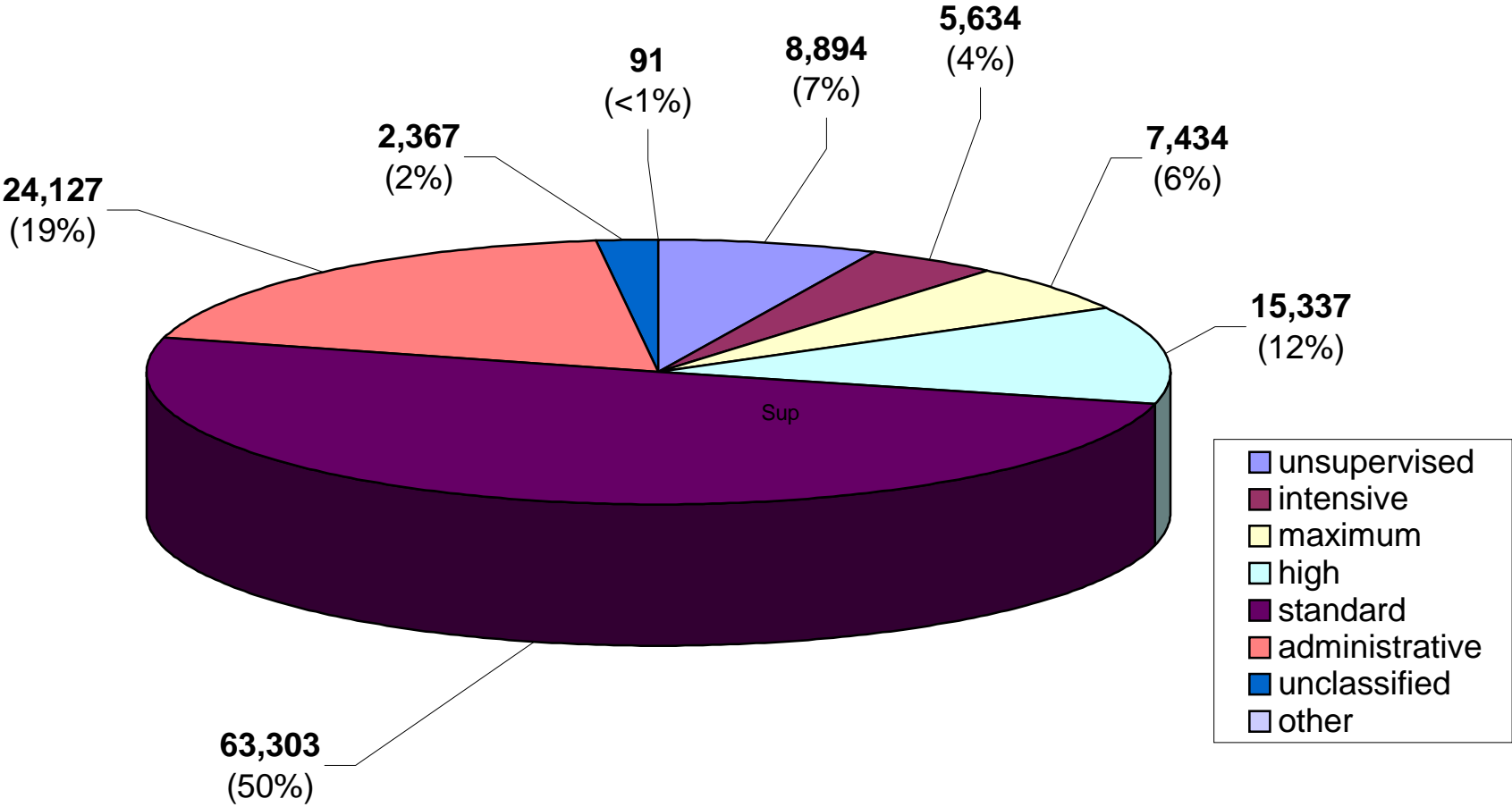


Senate Bill 474 took effect beginning January 1, 2001. This bill removes all new misdemeanor starts from the Department of Corrections jurisdictions.

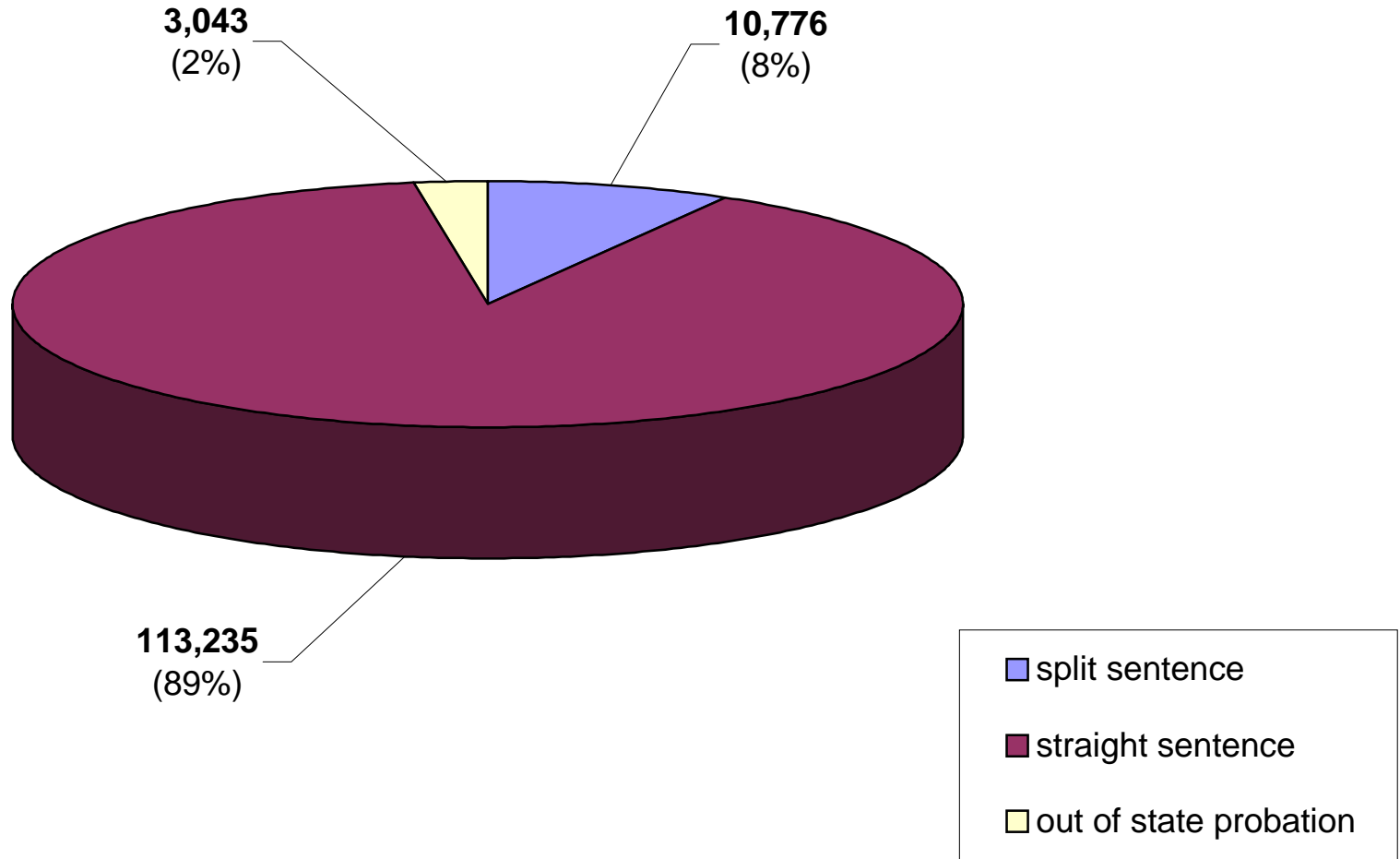
Active Probationers By Race & Gender



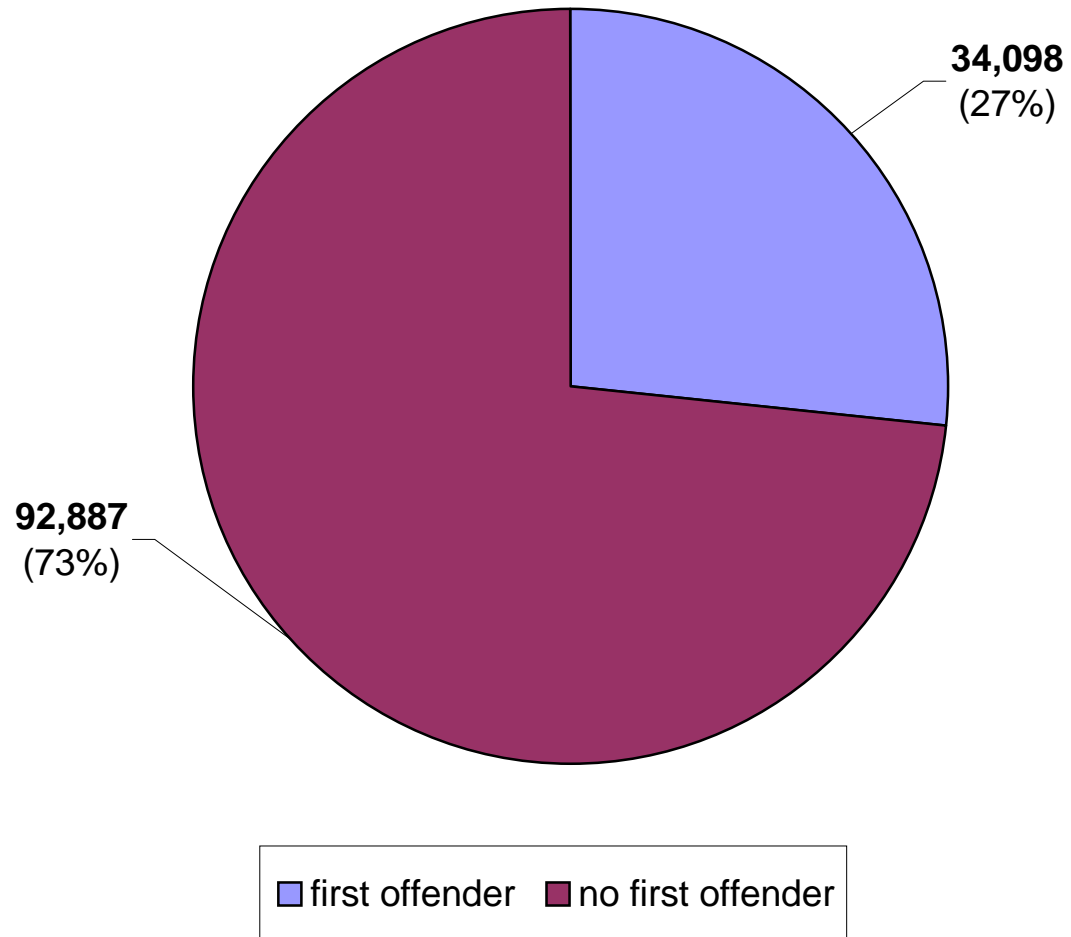
Active Probationers By Current Supervision Type



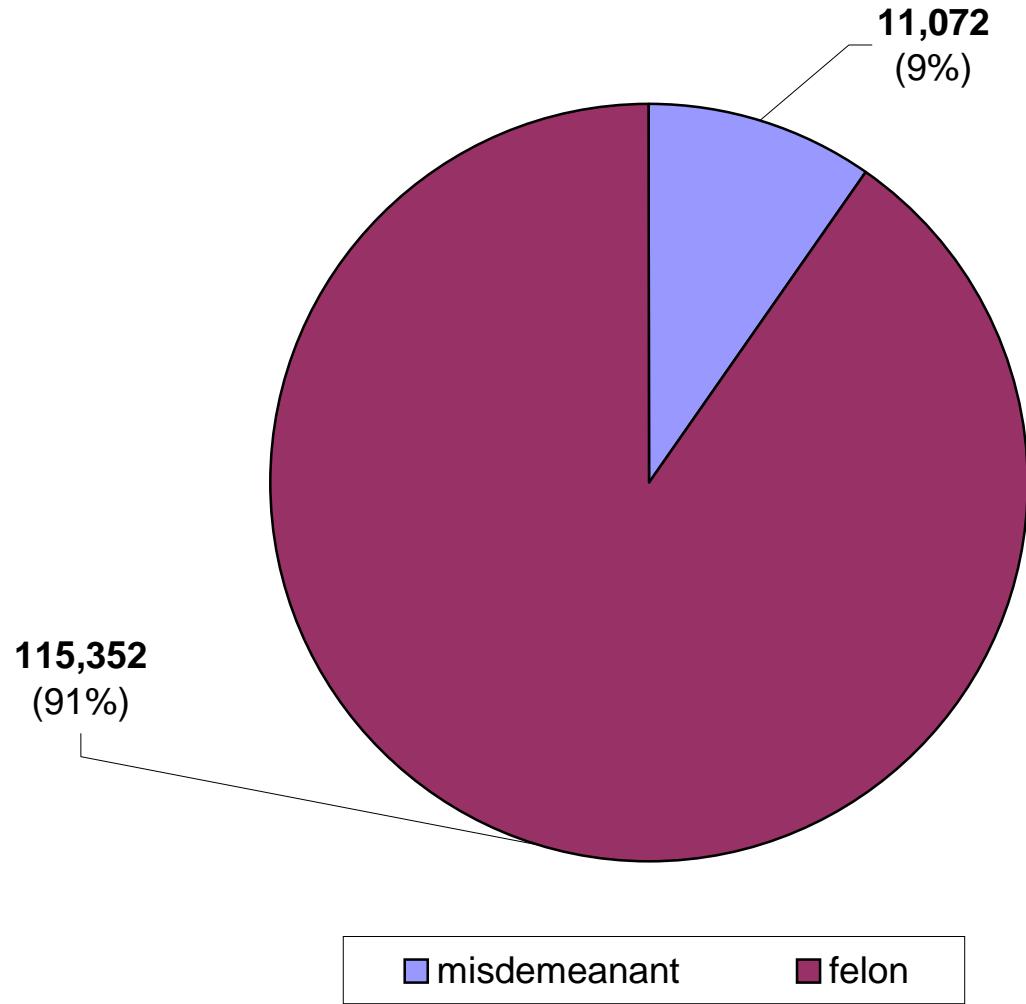
Active Probationers By Case Type



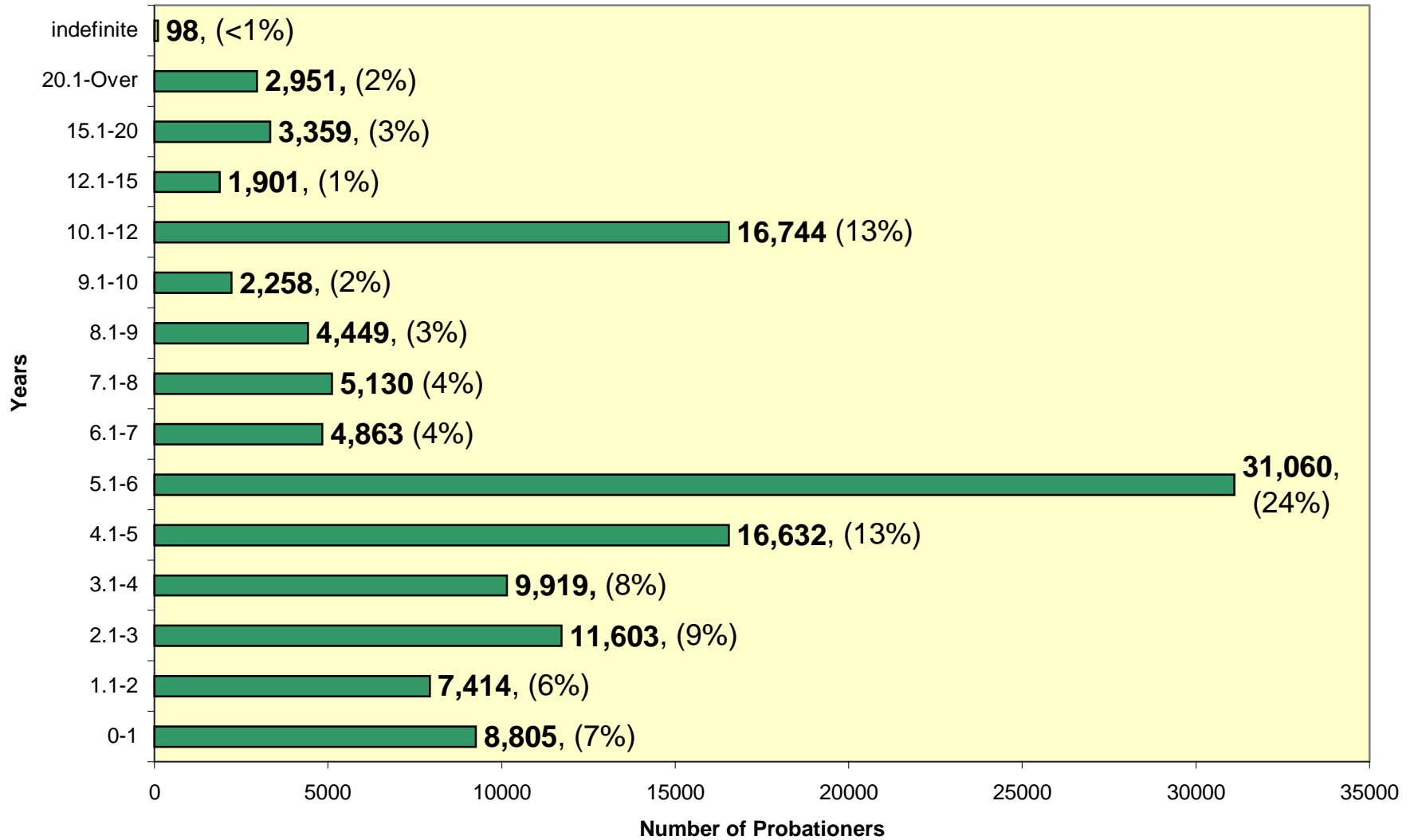
Active Probationers By First Offender Status



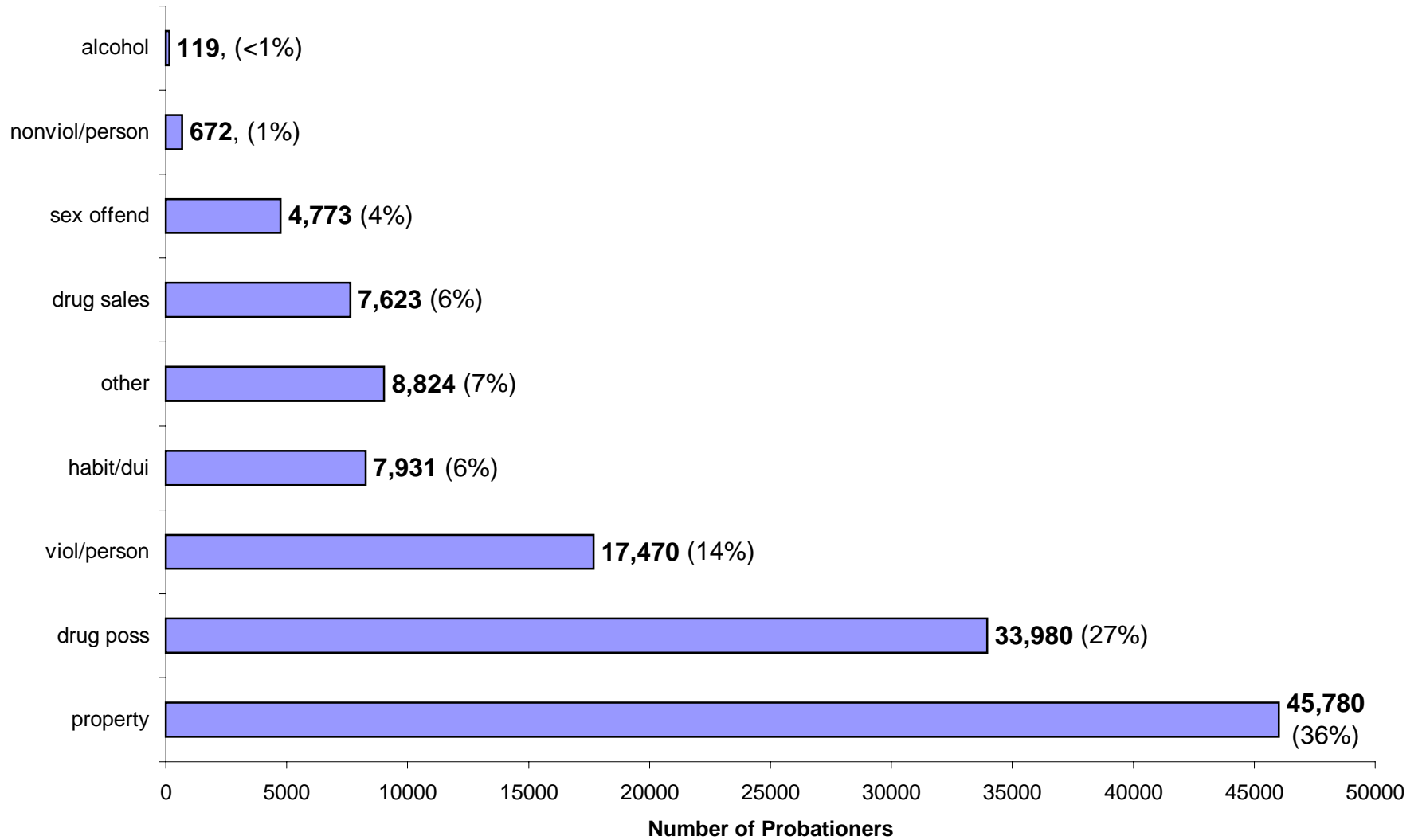
Active Probationer By Sentence Type
