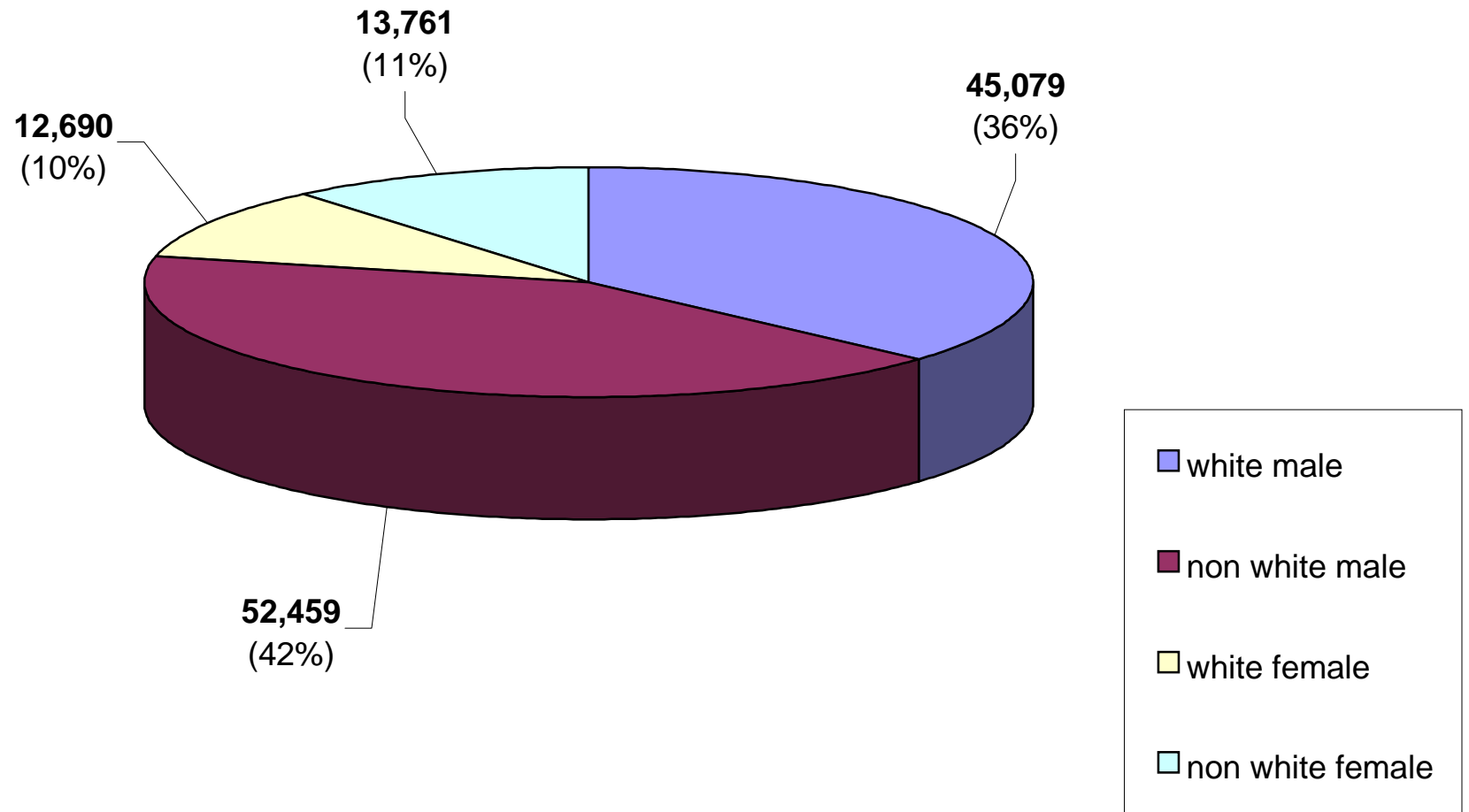
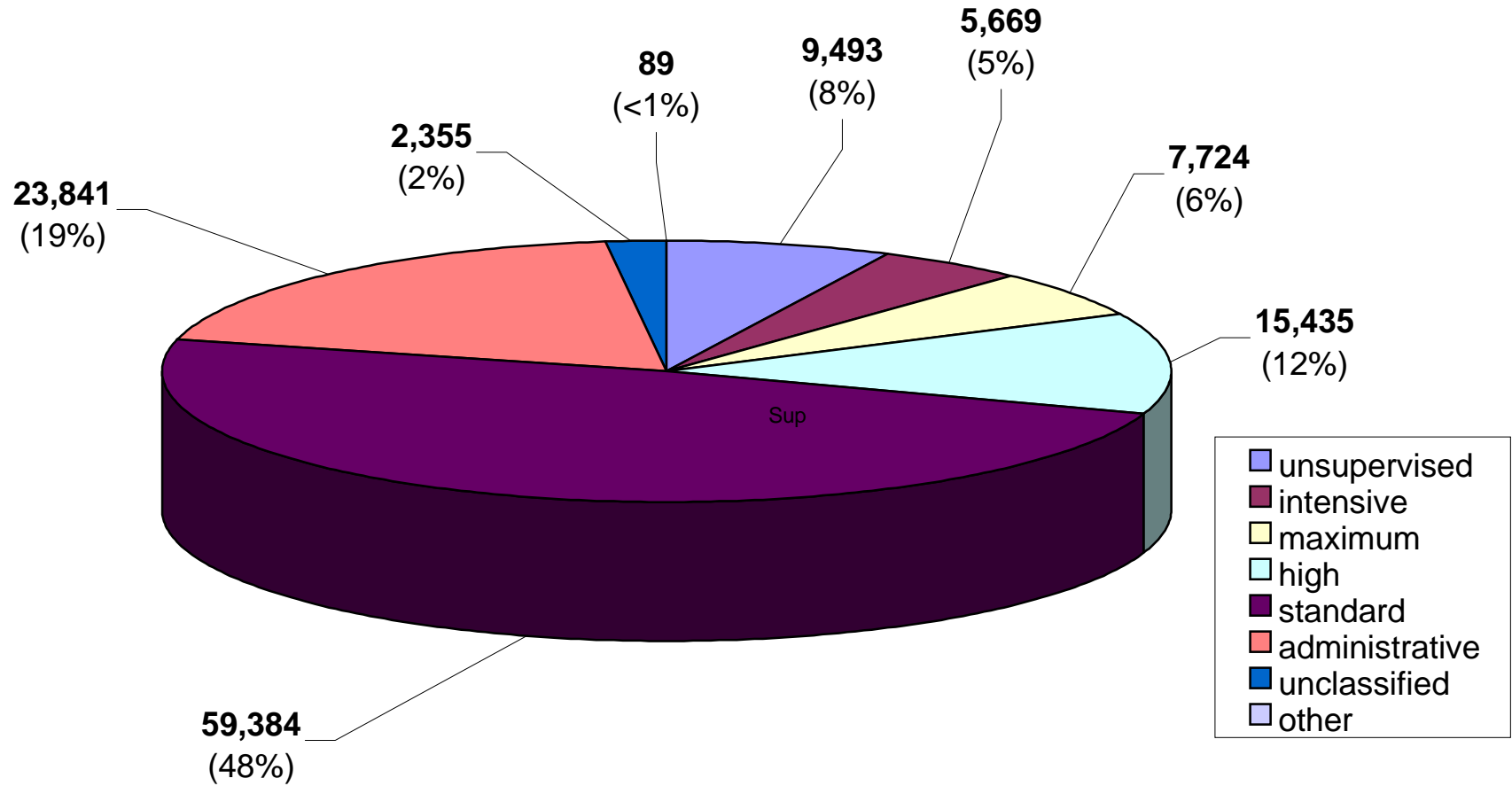


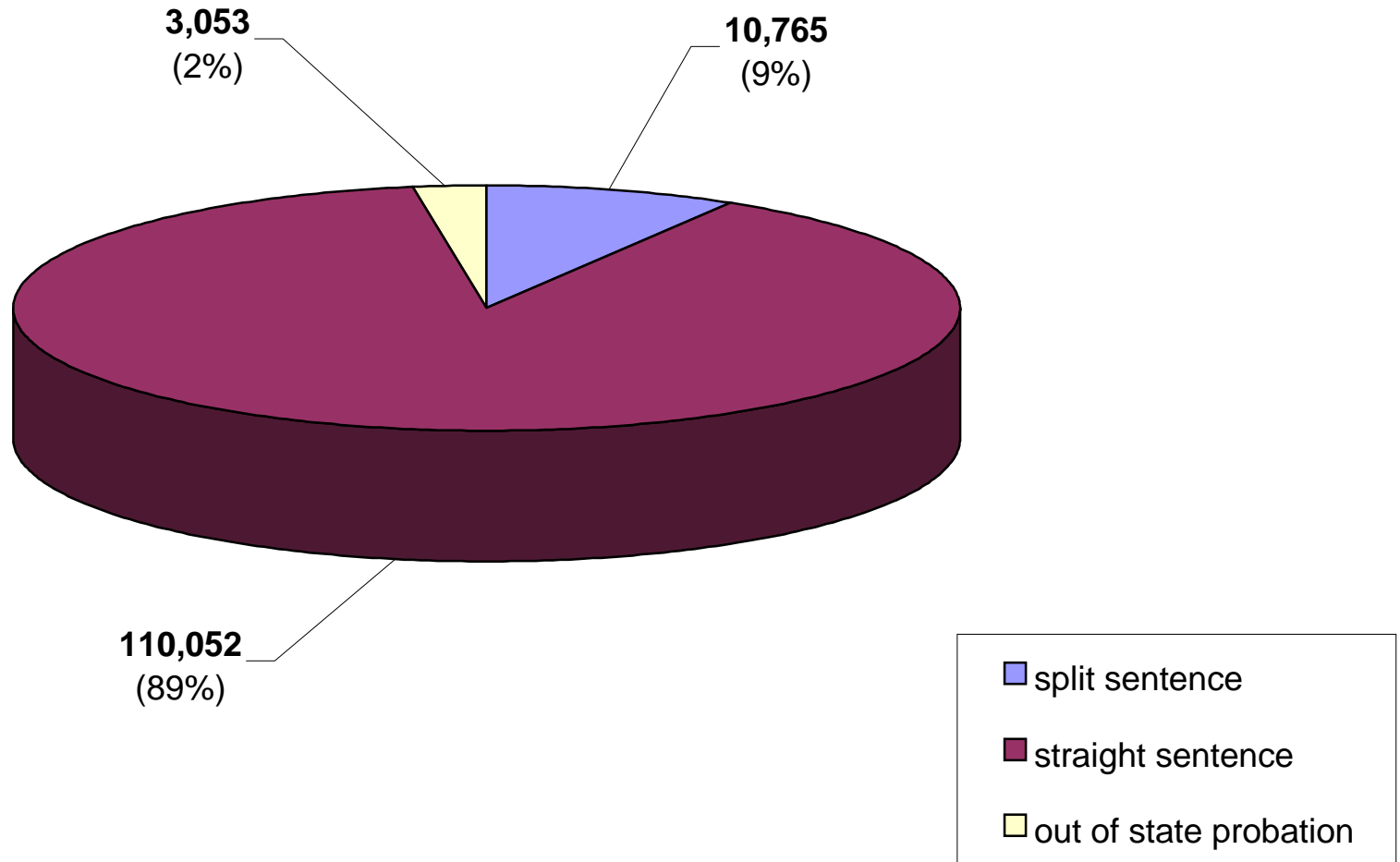
## Active Probationers By Race & Gender



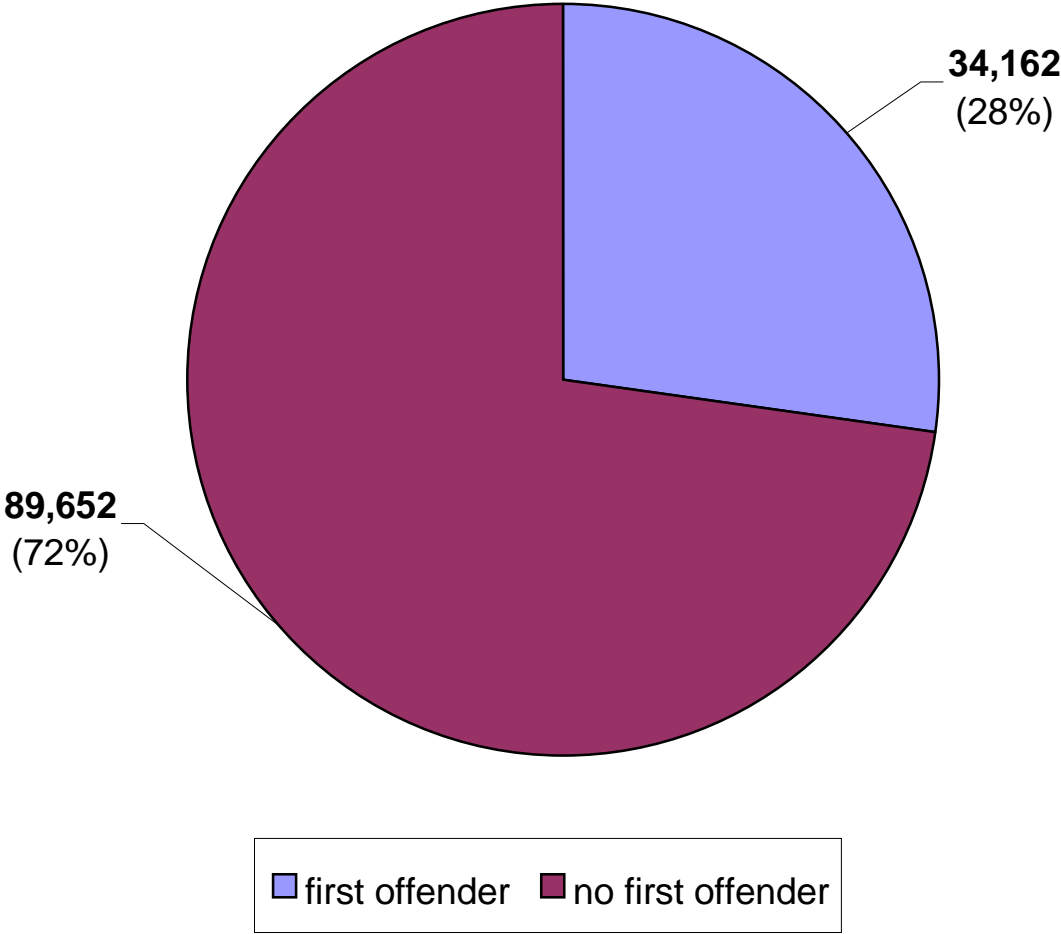
## Active Probationers By Current Supervision Type



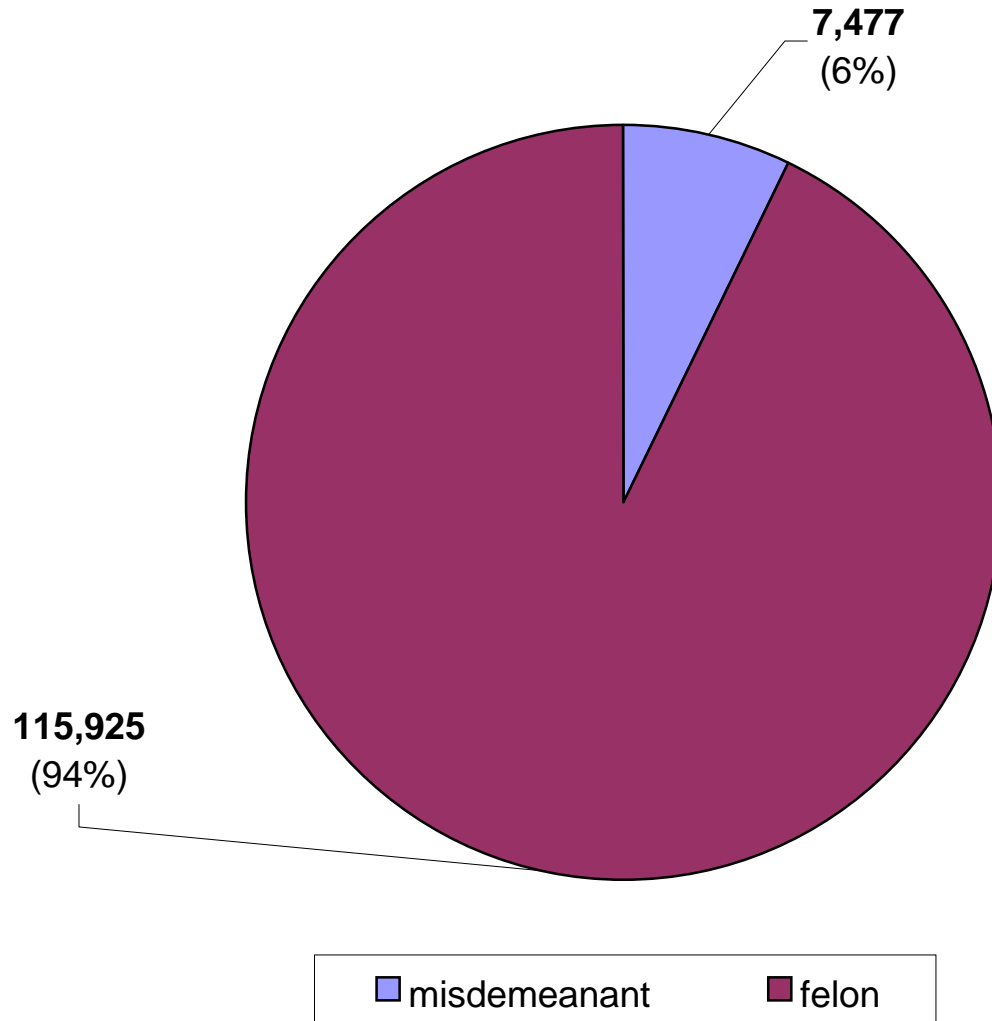
## Active Probationers By Case Type



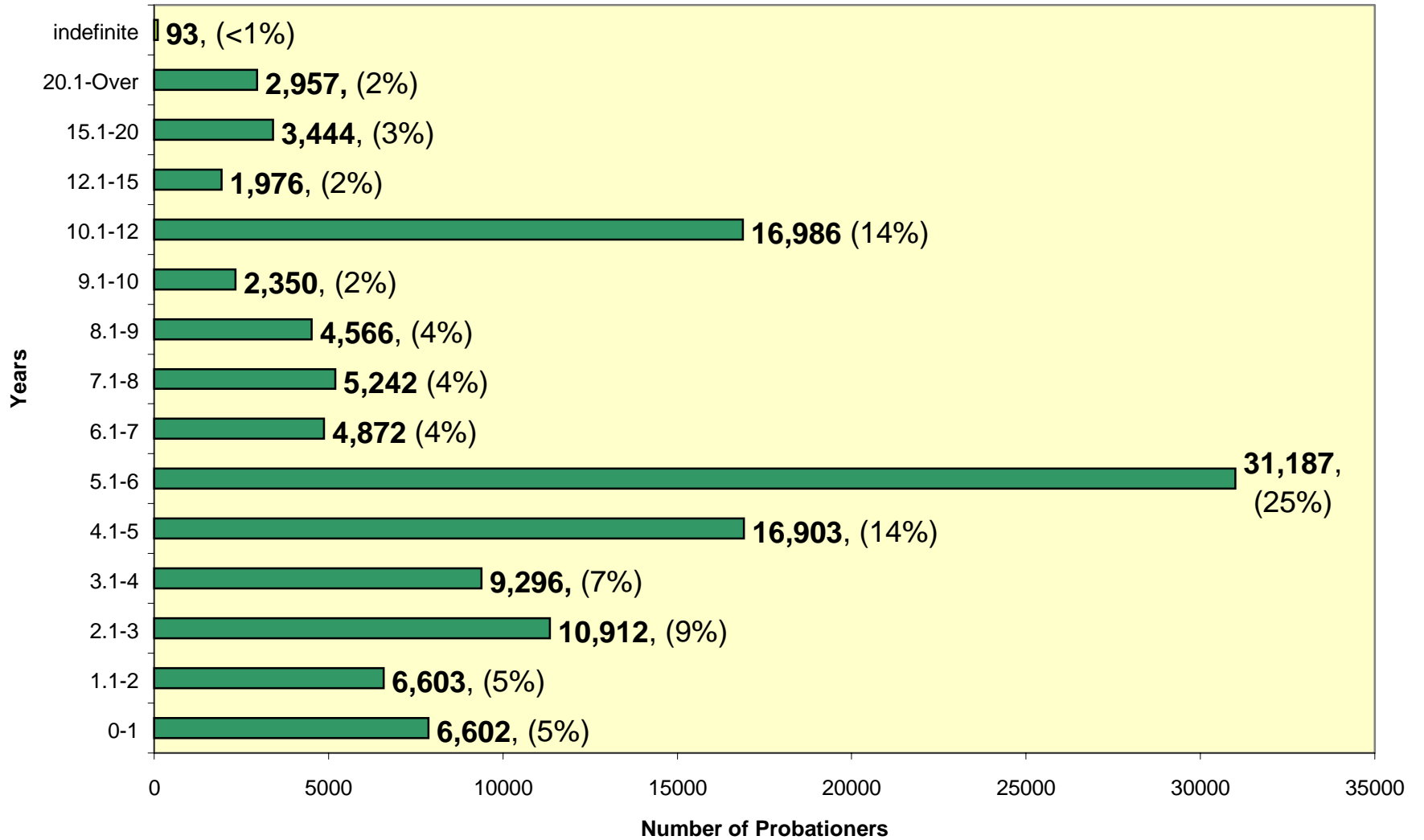
# Active Probationers By First Offender Status



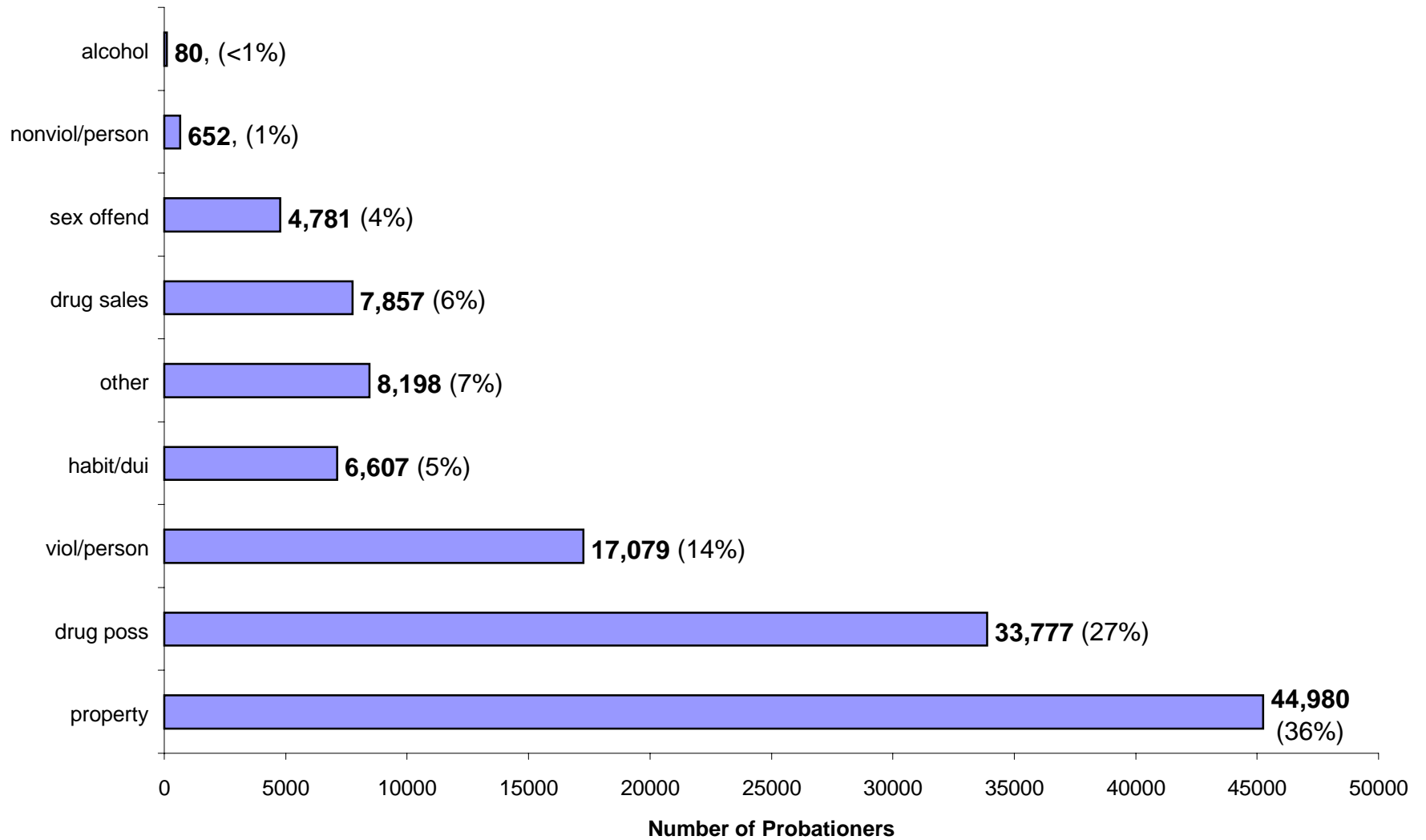
### Active Probationer By Sentence Type
